



## FedEx Retiree Discount Shipping Privilege Request Form

Per FedEx policy, to be eligible for this benefit, at the time of leaving the company, employees must meet all of the following criteria:

- Be at least 55 years of age or older
- Have voluntarily resigned
- Have at least 5 years of permanent continuous service
- Have a rehire status of "yes" or "conditional"

Note: Flying Tiger Line (FTL) employees who retired before the merger date of August 7, 1989 and Retired FedEx International based employees are not eligible for this benefit.

**All blanks must be completed in order to process your retiree discount shipping request. Incomplete forms will be returned. You will receive written notice when your discount shipping benefits are established. Your retiree shipping discount privileges cannot be established prior to your actual retirement date.**
